has violated the rules of ethics and conduct of the legal profession in that:

1. Refused to accept my financial information I mailed and faxed his office to accurately calculate child support based on true earnings as verified with Exhibits A-1, A-2, F-1, F-2, F-3, and F-4.
2. Refused to accept my and then therefore fabricated a "Child Support Guideline Worksheet" on my behalf to "REVERSE" calculate (prove) the desired child support amount set at \$1,600.00 per month... EXACTLY! ...claiming I earned \$127,200.00 per year! EXACTLY! ...as DecAnn Rae Johnson had so become accustomed to my GIFT since March 2007.
3. Knew I was faced with a deranged mother of my children who threatened I would never see my children EVER again unless I signed literally every wet signature document presented regarding Exhibit "M": "Decree Establishing Paternity, Custody, Child Support, & Visitation Rights."

Please see Exhibit "Q" State of California Public Employee Retirement pension benefit payment.


Dear Mr. Coy:
