for (2) seven days & then cremated.

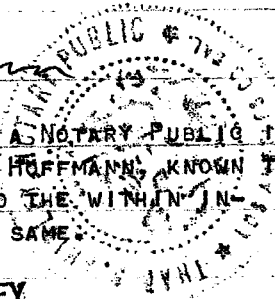
